

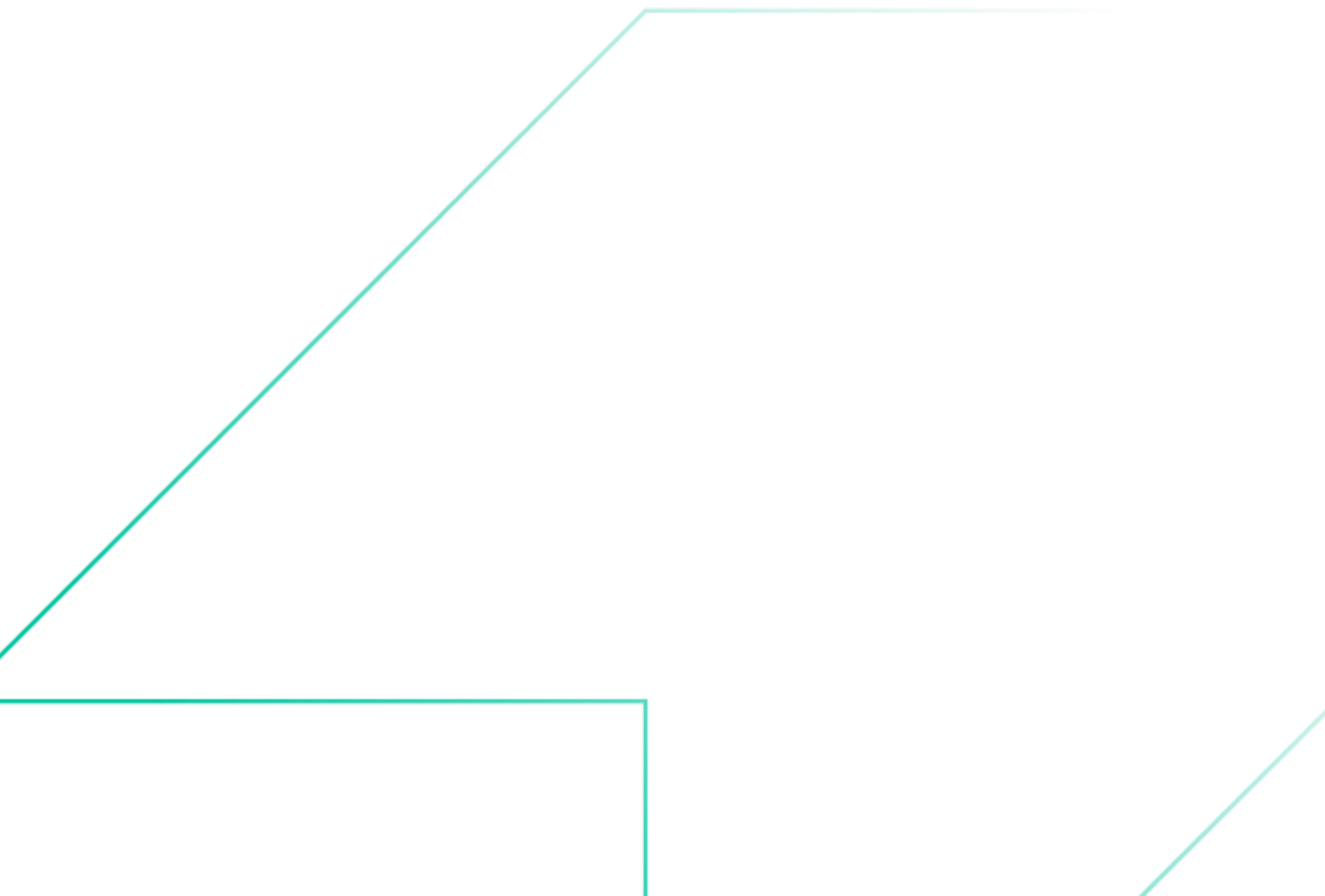

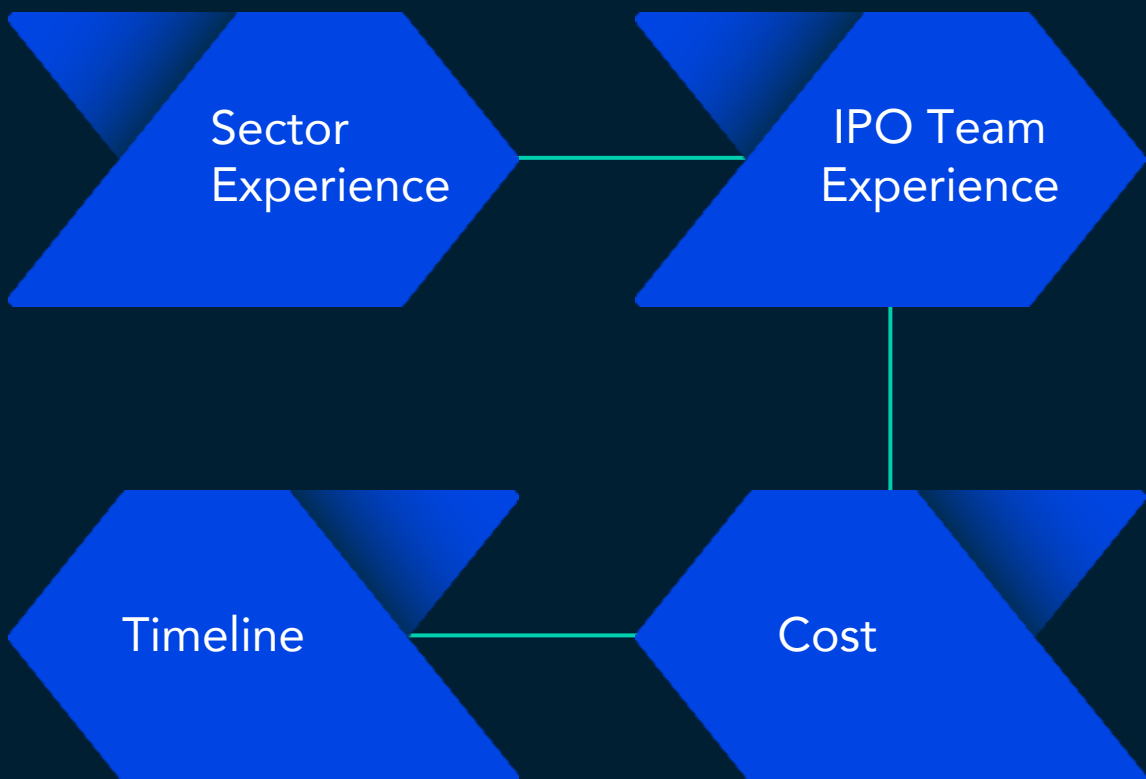

Details of Offerings and Listings in Various Markets on Saudi Exchange

During the Advisor Selection Stage, Several Considerations Should Be Taken into Account

While there is a substantial number of advisors licensed by the Capital Market Authority to support public offerings and listings, companies wishing to offer and list must appoint an advisor that aligns with their specific needs. During the advisor selection stage, the following considerations may be taken into account:



First: The Role of Financial Advisor



The role of a financial advisor begins in the pre-planning phase of the IPO by presenting the company's success story and developing a comprehensive strategy.

The financial advisor then undertakes the planning and implementation process, starting with appointing third-party advisors to carry out financial due diligence (FDD), legal due diligence (LDD), market research, and the PR/awareness campaign. They create a comprehensive project plan, appoint steering and operating committees, and review and evaluate all historical financial performance as well as future projections, key business drivers, and risks.

The advisor selects the appropriate valuation methodology, builds the financial model, recommends the offering price range, leads the development of offering materials and required documentation, advises the issuer on governance and regulatory frameworks, prepares the prospectus, develops a capital expenditures plan, gauges market interest in the offering, prepares the IPO submission file to the CMA and Saudi Exchange, and incorporates any feedback to secure approvals in an expedited manner.

The final stage is the offering and book-building process, through which the final share price is determined. Settlement then takes place, and trading of the security begins.

Second: The Role of Legal Advisor



Regulatory rules governing offerings and listings require the mandatory appointment of a legal advisor for companies seeking to list on the Main Market. In contrast, for listings on Nomu – the Parallel Market – appointing a legal advisor is optional.

The legal advisor plays a pivotal role in ensuring compliance with all legal and regulatory requirements throughout the listing process. Their responsibilities include verifying the accuracy and completeness of all documents, such as the request for placement and listing, board resolutions, board member affidavits, the prospectus, and all relevant supporting documents.

Additionally, the legal advisor is instrumental in preparing the legal due diligence report, drafting various sections of the prospectus, and supporting the company through any legal or corporate restructuring processes.

Third: The Role of Legal Accountant



The regulatory rules governing offerings and listings require the compulsory appointment of a certified public accountant for any company seeking to list.

The role of the legal accountant primarily involves reviewing and evaluating the financial statements of the company intending to offer and list. While their scope of work is typically limited to reviewing the company's financial accounts, in some cases this may extend to reviewing other financial data — such as pro forma financial statements — to retrospectively reflect changes in the company's financial position and results of operations due to events like a restructuring.

Additionally, the chartered accountant is responsible for preparing a financial due diligence report in accordance with the required disclosure standards, as well as a report on the company's working capital.

Selecting Financial Advisor and a Legal Accountant for Your IPO



The Capital Market Authority (CMA) grants licenses to advisors who are qualified to provide services related to the offering and listing of issuers. The financial advisor acts as a representative of the company and provides the necessary guidance to ensure compliance with the regulatory requirements of the relevant authorities.

The CMA also maintains a list of accounting firms and chartered accountants registered to practice auditing for listed companies and investment funds.

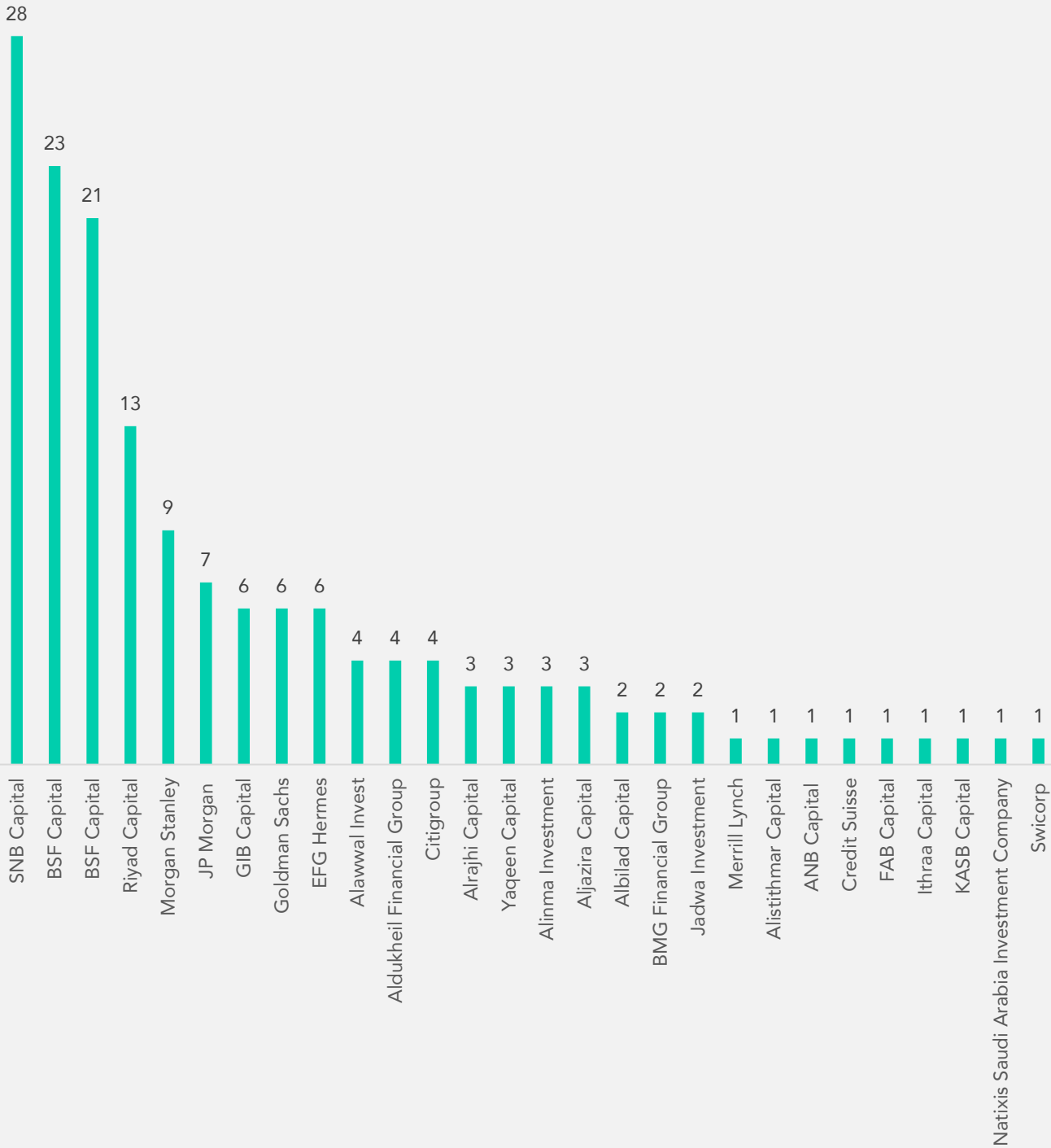


Financial Advisors Participation by Sector

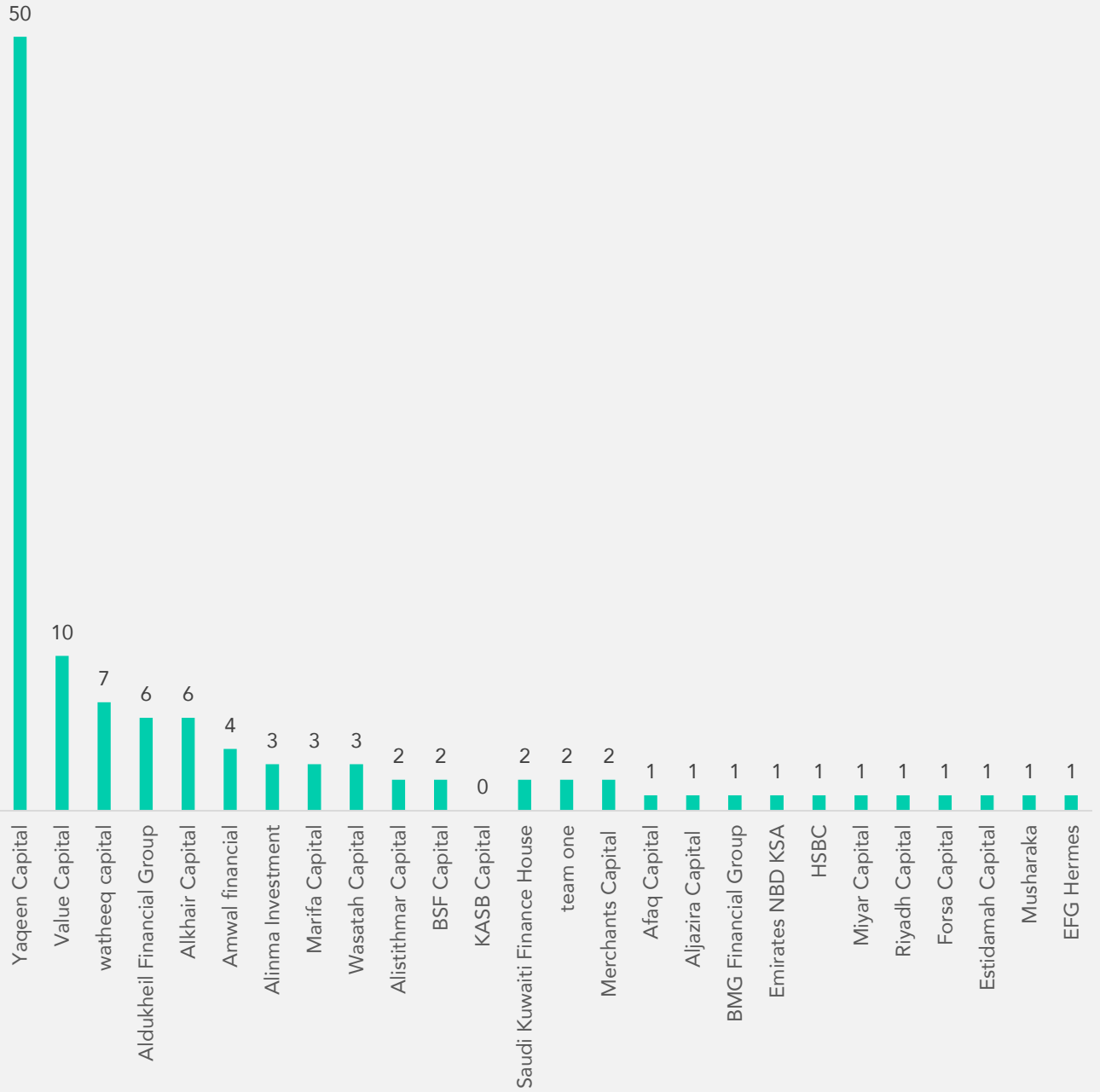

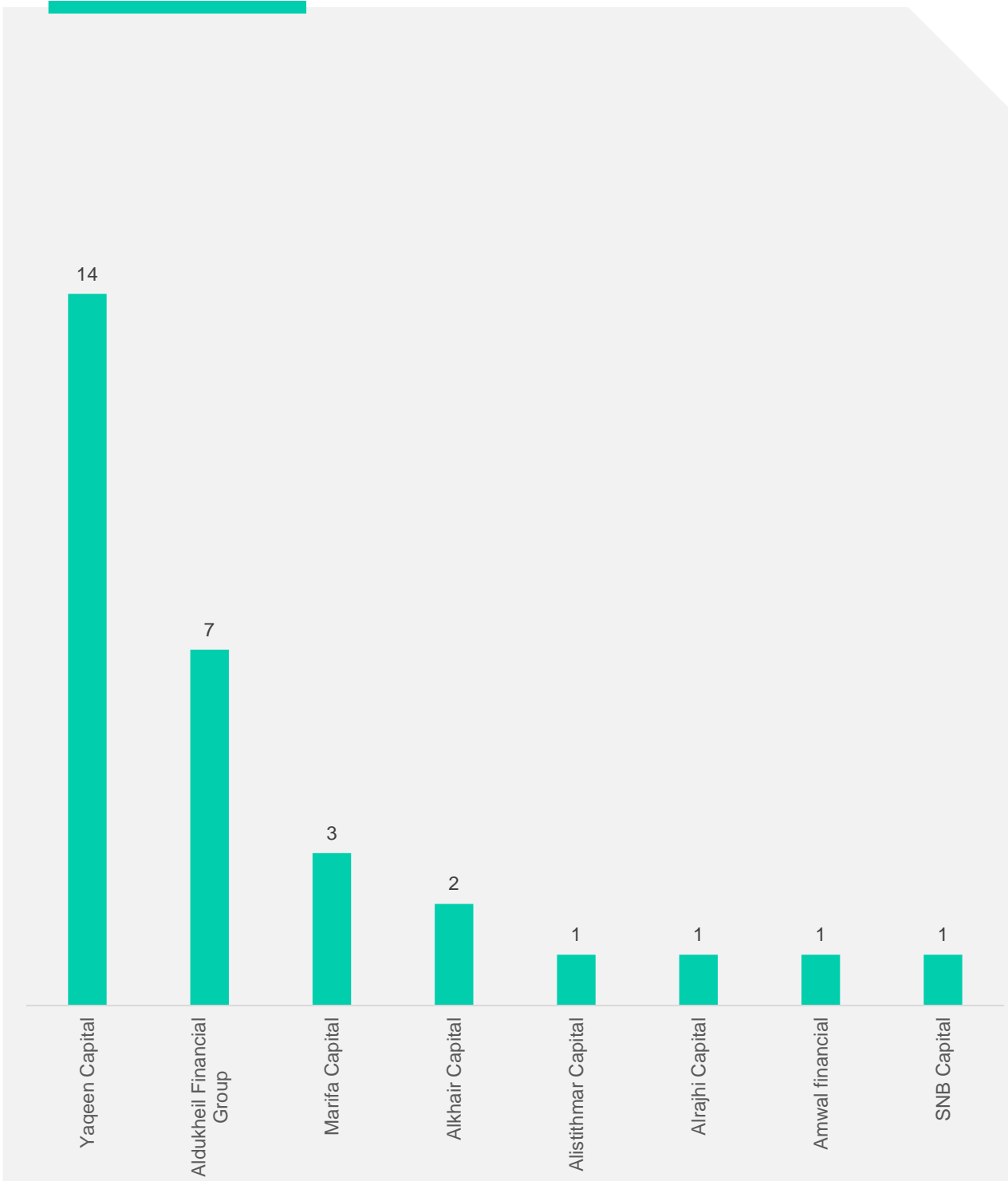

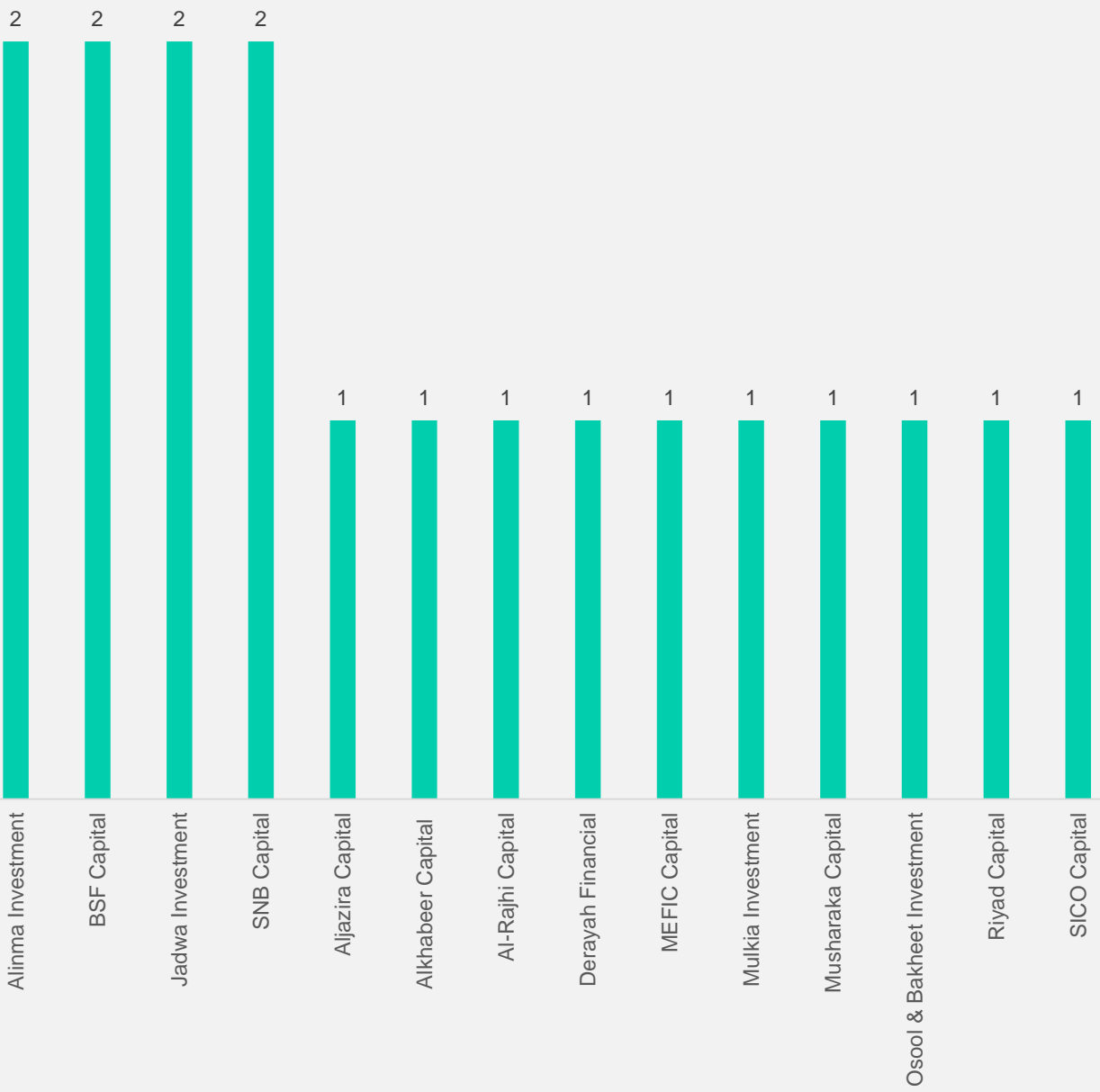


Since 2020, 8 Financial Advisors Have Participated in Nomu – Parallel Market Direct listings

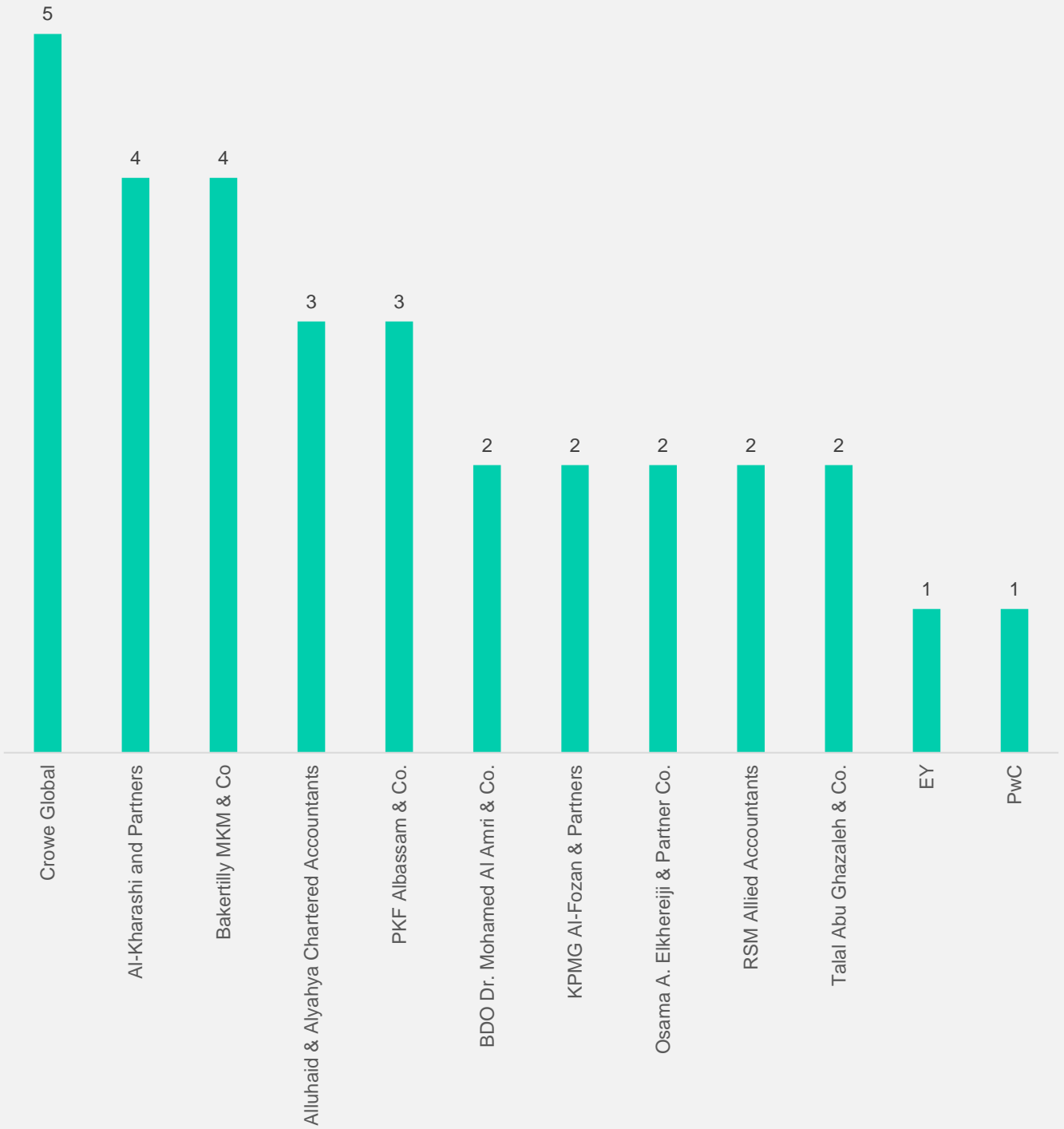

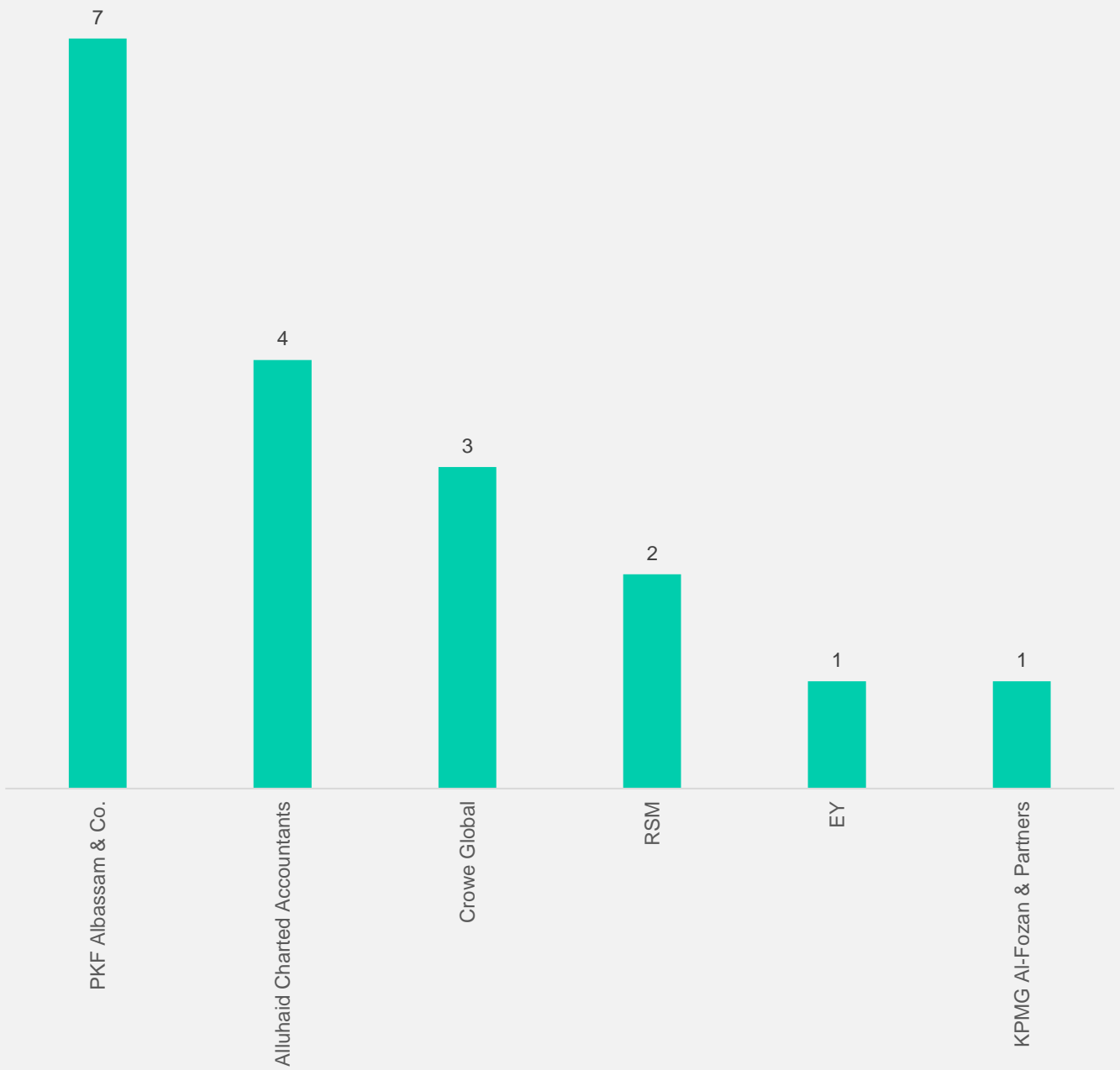
